2. Scope of Work:

Scope of work comprises of renovations of brick pathways in two areas:

- (i) Brick pathways from the security guard room at the entrance, through the driveway towards the front entrance of the Chancery (area approx 583 square meter). Scope of work includes:
 - Lifting of old bricks and their cleaning
 - Excavate 50 mm and cart away
 - Slope area to gain correct paving levels
 - Water and compact sub-base layer to optimum density
 - Import crusher and stabilize with 3% cement
 - Re-installing of old bricks
 - Wash-in cement grouting to all joints (32.5mpa cement)
 - Attend to all cement joining and pointing
 - Cleaning of site

Note: The above area comprises of approx 28 square meter passage area which will require installation of new bevel bricks.

- (ii) Brick pathways from from the High Commission of India's entrance from Eastwood Street side, through the driveway towards parking area and around the parking area (area approx 710 square meter). Scope of work includes:
 - Removal of old bricks and cart away
 - Excavate 50 mm and cart away
 - Slope area to gain correct paving levels
 - Water and compact sub-base layer to optimum density
 - Import crusher and stabilize with 3% cement
 - New bevel bricks to be installed
 - Wash-in cement grouting to all joints (32.5mpa cement)
 - Attend to all cement joining and pointing
 - Cleaning of site
- (a) The firm shall ensure that the water/drainage/irrigation pipes under the brick pathways are not broken or damaged during the work.

- (b) Period of product warranty and workman ship guarantee to be included in the bid.
- (c) Time frame to complete the work after award of the job to be included in the bid.
